<b>Comprehensive Medical-Legal Evaluation (ML-201)</b> – includes initial evaluation; plus \$3.00/page record review over 100 pages	2,950
<b>Follow-Up Medical-Legal Evaluation (ML-202)</b> – plus \$3.00/page record review over 50 pages	1,975
<b>Supplemental Medical-Legal Evaluation (ML-203)</b> – plus \$3.00/page after first 25 pages	1,250

Psychiatric Evaluations & Reports (Legal / Immigration)	Fee
Legal or Immigration Psychiatric Evaluation (includes psychiatric note; report billed separately)	1,500
Consultation Evaluation Report (includes first 3 pages)	1,200
Each Additional Report Page (beyond first 3 pages)	275

Medical Legal Testimony	Fee
Medical-Legal Testimony (ML-204) – \$850/hour, <b>2-hour minimum</b>	1,700
<b>Court Testimony</b> – \$850/hour, <b>8-hour minimum (full-day hold) *</b>	6,800
<i>* Court testimony requires advance scheduling; the entire day is reserved exclusively; all other clinical and administrative services will be cancelled or rescheduled</i>
