AMSMC FEE SCHEDULE ADDENDUM / PAYMENT POLICY (ALL SERVICES)


This fee schedule applies to all payers, including **attorneys, legal representatives, insurance carriers, courts, and medical-legal matters**. Services rendered under this schedule are **independent medical-legal expert services, not medical treatment, and are not billable to health insurance**.

Retainers, Pre-Payment & Liens
All medical-legal services require advance payment or a written attorney retainer agreement , unless otherwise agreed in writing.
When services are requested on lien , the lien must be in writing , signed by both the patient and attorney of record , and is enforceable against settlement proceeds under California law.
Attorney and law firm are jointly and severally responsible for all fees incurred, regardless of: Case outcome, Settlement amount, Client's refusal or inability to pay
Reduction, compromise, or non-collection of settlement funds does not extinguish the fee obligation .

Subpoenas, Record Review & Statutory Compliance
Subpoenas must comply with California Code of Civil Procedure §§ 1985–1987 , HIPAA, and the California Confidentiality of Medical Information Act (CMIA) .
Receipt of a subpoena does not waive professional fees .
Review time, document production, declarations, and compliance activities are billable medical-legal services .
Statutory witness fees and mileage do not replace or satisfy professional fees for expert services.

- Fees are **due before or at the time of service**, or must accompany the written request.
- Services will not be rendered until payment is received unless prior written arrangements are made.
- **All fees** may be adjusted annually, generally within the range of 5–7%, effective January 1 of each calendar year, based on changes in operating costs, inflation, and any such adjustments are intended to be modest and consistent with customary medical practice standards.
- Missed appointments or late cancellations may be subject to additional charges.
- **Late Payment & Collections (California)** Payment is due upon receipt. Balances unpaid after **30 days** accrue interest at **1.5% per month** or the maximum rate permitted by California law. Attorney and law firm are **jointly and severally liable** for all unpaid amounts and reasonable collection costs, including attorney's fees. AMSMC may pursue collection, enforce its lien against settlement proceeds, and **withhold reports, testimony, or further services** until paid in full. Partial payment does not waive the remaining balance. **Failure to remit payment within 30 days authorizes AMSMC to enforce its lien directly against settlement proceeds without further notice**
