**AMSMC FEE SCHEDULE / ATTORNEY RETAINER ADDENDUM
(Medical-Legal Services)**

This Addendum forms part of the attorney’s request for services from **Access Multi-Specialty Medical Clinic, Inc. (AMSMC)** and /or **Michael U. Levinson, MD, PhD** and applies to all payers, including attorneys, legal representatives, insurance carriers, courts, and medical-legal matters. Services rendered under this schedule are independent medical-legal expert services, not medical treatment, and are not billable to health insurance.

1.	Nature of Engagement
	Services are rendered solely as independent medical-legal expert services , not as treatment.
2.	Fees & Retainer
	Attorney agrees to pay fees in accordance with AMSMC Fee Schedule B in effect at the time services are rendered. Retainer or full pre-payment is required prior to commencement.
3.	Attorney Responsibility
	Attorney and law firm agree to be jointly and severally liable for all fees incurred, irrespective of case outcome or client payment
4.	Liens
	Acceptance of a lien does not waive the attorney’s independent obligation to pay. Any lien must be signed by attorney and client
5.	Subpoenas & Testimony
	Compliance with subpoenas, depositions, or court testimony requires advance payment and scheduling confirmation. Statutory witness fees are not accepted in lieu of professional fees.
6.	Cancellations
	Cancellations with fewer than 5 business days’ notice may be billed in full.
7.	Late Payment & Collections (California)
	Balances unpaid after 30 days accrue interest at 1.5% per month or the maximum rate permitted by California law. Attorney and law firm are jointly and severally liable for all unpaid amounts and reasonable collection costs, including attorney’s fees. AMSMC may pursue collection, enforce its lien against settlement proceeds, and withhold reports, testimony, or further services until paid in full. Partial payment does not waive the remaining balance. Failure to remit payment within 30 days authorizes AMSMC to enforce its lien directly against settlement proceeds without further notice.
8.	Governing Law
	This agreement shall be governed by the laws of the State of California
